Teaching Innovations

Co-Developer and Guest Instructor, *SPHL709: Reading Public Health Emergencies Through Information and Communication Research and Policy.* I co-developed this new course, which is an introduction for graduate students in any discipline to research on public health emergencies. In this course, faculty working on the Grand Challenges Pandemic Readiness Initiative, which I co-direct, help students build foundational knowledge on information and communication issues for future coursework and research. The course was offered for the first time in winter 2024.
